

## MARCH 9, 2016

The regular monthly meeting of the Hiles Town Board was held on Wednesday, March 9, 2016. Call to order was by supervisor Brian Bukovic in the absence of chairman Tauer. Present: Lovrine, Bukovic and clerk Votis. Treasurer McKay-Burkey was also absent. Agenda read. Motion to accept Lovrine. Second Bukovic. Motion carried. Minutes of Feb read. Motion Lovrine to accept. Second Bukovic. Motion carried. Clerk read treasurer's report. **OFFICER & COMMITTEE REPORTS:** Clerk read letter received from Forest County Land and Water on the nuisance complaint at 10531 Coes Landing: Their findings are that he is not in violation of the nuisance ordinance. They will follow up on this in the spring. Letter and pictures from Georgianna Starz of Camp Nicolet with concerns of damage being done by the town plow when it turns around using their circular driveway. Board will look at this on their annual roads survey. Lastly, Lynn Black from the forest county highway office sent a letter telling the board that this year would be a good time to do black topping of roads as oil prices are low. Clerk told the board that the annual town meeting has to be on Tuesday, April 19, 2016 and asked if they wanted to have the regular monthly meeting to follow on that date instead of the second Wednesday of the month. Board agreed to this. Bukovic told that Great American Disposal contacted him with request to have the permission letter faxed to them to go on posted roads for garbage removal as in the past. Clerk had already done so. He also stated the R Value will come next week to look over the town hall ceiling and submit a proposal. Lovrine contacted Bob Machon concerning if the state received our passer rating. He called the state and made sure they had. She also has been trying once again to talk to Bob Winot on the Four Duck Lk Rd issue and no reply!! Board decided to go on the annual roads survey April 4, 2016. Hiles Planning Committee: Mark Ferris reported on their meeting highlighting broadband/internet and the implementing of a face book page which they will be responsible for. Board is okay with this and will view it next month. **CITIZENS INPUT:** Jesse Houle owner of the land at 10531 Coes Landing asked the board who filed the nuisance complaint. Board told him that they did not know. Letter came from the county and the complaint was filed with them not the town. He stated that he has the freedom to do whatever he wants on his land. Bill Biemborn asked about road limits. Clerk had talked to Tauer and he said they should go on this Friday. After discussion it was decided they were to go on this Monday. **READING & APPROVAL TO PAY VOUCHERS:** Motion by Bukovic to approve for payment vouchers #18044 to #18082. Second Lovrine. Motion carried. Motion to adjourn Bukovic. Second Lovrine. Vote all aye. Meeting adjourned at 8 p.m.
